Pasture Requirement				
<u>Space</u>	The minimum outdoor space requirement is 2.5 acres/1000 birds (108 sq.ft/bird) (R 1c).	AWA standards require that all birds are pasture raised. Must have continuous access to at least 4 sq.ft range and foraging area (5.4.11).	No requirements.	Outdoor access required. No specific requirements for space specified.
<u>Time Outdoors</u>	Birds must be outdoors 12 months per year, every day for a minimum of 6 hours per day. In an emergency, the hens may be confined in fixed or mobile housing 24 hours per day for no more than 14 consecutive days (R 1g).
