


<u>GROWTH</u>

- This year, <u>96.7 million farm animals</u> were raised under HFAC's standards, an increase of 9,179,023 million farm animals in 2014 raised under our standards and inspected to ensure that all of our standards are met on farm through slaughter, which was made possible only through our donors and volunteers. In addition, consumers have benefitted from not consuming unnecessary antibiotics and animal byproducts. Farmers have also benefitted by being supported and recognized for their superior farming practices.
- In 2014, 127 companies represented more than 4,900 farms that are Certified Humane[®] in the U.S., Canada, Brazil and Peru. In 2014, 16 new companies joined the Certified Humane[®] program. Certified Humane farms and ranches are located in 45 States and 4 countries.

Certified Humane[®] App Now Available in Four Languages

In 2014, consumers in Canada, Brazil and Peru could now find Certified Humane® products in local stores – and in their native language, thanks to HFAC's program expansion and recently upgraded Certified Humane® App. In addition to English, HFAC's expansion into North and South American countries now means the Certified Humane® App will include Portuguese, Spanish, and French language options for customers.



In a year's time, the number of supermarkets carrying Certified Humane[®] products has doubled as a result of demand from our App users. The increased presence of Certified Humane[®] in the international market serves as a testament to the benefits of our program on a global scale.

Open Farm is the First Major Dry Pet Food Company in Canada to Receive the Certified Humane[®] Label



Since HFAC launched in 2003, pet owners have been clamoring for pet foods containing meat and chicken that were Certified Humane[®].

In November, HFAC certified Open Farm, a Canadian-based pet food company, as the first producer of Certified Humane® Raised and Handled® dry pet foods in Canada. Open Farm launched their Certified Humane® dog food products in stores across Ontario, Quebec and the Maritimes. Under the Certified Humane® Raised and Handled label, Open Farm will use only meat and poultry products in their pet foods that come from Certified Humane® farms and ranches. Open Farm plans to expand their Certified Humane® pet food product line into Western Canada and the United States in 2015.
