Since 2003, more than half a billion farm animals have been raised under the Certified Humane<sup>®</sup> program – in five countries.

This success can be attributed to the growing number of consumers who want to know how their food is raised and are demanding that cows, pigs, chickens, laying hens, and other farm animals are raised in compassionate ways. They are making a difference by shopping for Certified Humane<sup>®</sup> products in the marketplace and letting their grocers know they want Certified Humane products in the stores.

As a result, we are making excellent progress. In

fact, farmers now often call us to become Certified Humane<sup>®</sup>, so they can show their unwavering commitment to farm animal welfare.

### Who is Certified Humane<sup>®</sup>?

Humane Farm Animal Care (HFAC) is an international nonprofit certification organization dedicated to improving the lives of farm animals in food production from birth through slaughter. The goal of the program is to improve the lives of farm animals by driving consumer demand for kinder and more responsible farm animal practices.

The Certified Humane<sup>®</sup> label on meat, poultry, egg, or dairy products assures consumers that the the animals were raised according to our *Animal Care Standards* for humane farm animal care. Farms must adhere to all these standards to qualify for the Certified Humane<sup>®</sup>label.

On Certified Humane<sup>®</sup> farms, animals are never confined to battery cages, gestation crates, or tie stalls. Animals must receive a nutritious diet without antibiotics or hormones and be raised with shelter, resting areas and space to support natural behaviors, such as flapping their wings, perching, or rooting, depending on the species.

To ensure these standards are met, Humane Farm Animal Care relies on veterinarians and animal welfare scientists – all specialists with specific farm animals – to inspect farms annually. Third-party independent inspections of farms verify compliance with the Animal

*Care Standards* and traceability audits ensure the products comes from Certified Humane<sup>®</sup> farms. Producers must comply with food safety and environmental regulations. Processors must comply with the American Meat Institute Standards (AMI), a slaughter standard written by Dr. Temple Grandin, a member of HFAC's Scientific Committee.



## Our Focus is Only Farm Animals

At Humane Farm Animal Care, we only do one thing -- work to improve the lives of farm animals in food production. What that means is all day, every day, all we do is:

- <u>Encourage farmers</u> to join the Certified Humane<sup>®</sup> program to ensure farm animals can lives free of cages and gestation crates and live more natural lives on the farm.
- <u>Contract third-party inspectors</u> to inspect and audit farms to ensure farm animals are raised according to our precise standards of care.
- <u>Educate consumers</u> about how to support compassionate farmers by shopping and asking for Certified Humane products in their local grocery stores.





### Who's behind Certified Humane®?

### Our Staff

Our Executive Director and Founder, Adele Douglass launched Humane Farm Animal Care in 2003. Under her leadership, the Certified Humane® program has expanded into five countries and brought more than a half billion farm animals into the program. A longtime animal advocate, Douglass is the recipient of an RSPCA Overseas Award, an ASPCA Lifetime Achievement Award, an Ashoka Fellow, and a Purpose Prize. Offices in North and South America are lead by people who are passionate about the well-being of farm animals.

#### **Our Scientific Committee**

Humane Farm Animal Care's Animal Care Standards are not written by staff, but by a 40-person scientific committee made up of the world's top farm animal welfare scientists – folks with with Ph.D's, and DVM's in farm animal care. These experts create standards for every farm animal in our program, and they review and update standards, as needed. They're committed to creating a future where farm animals are raised humanely throughout their entire lives.

#### **Third-Party Inspectors**

Humane Farm Animal Care engages independent thirdparty inspectors, also experts in their specific field, to inspect and audit farms to ensure compliance with standards. Only a laying hen expert can inspect an egg farm, and a pig expert can inspect a pig farm. When inspectors are experts in their field, they know best when a standard is being met every day and not just for the day of inspection.

### What makes the Certified Humane<sup>®</sup> program different from other certification programs?

1. Some certification organizations allow a phase in period, we do not. Anyone applying to the Certified Humane<sup>®</sup> program must meet all of our standards before they can be certified. There is no "phase in" period allowed.

2. Our third-party inspectors must have a masters or PhD in animal science or a veterinary degree. In addition, they must have expertise in a specific species so when they're doing an inspection they know if what they are seeing has simply been set-up to look good or if humane practices are really being used on the farms all the time.

3. No other humane certification organization has a scientific committee as comprehensive as ours. HFAC's scientific committee is considered the "who's who" of farm animal welfare work. These scientists hail from all over the world and are as eager as we are to see farm animals raised more humanely. The entire body of their work is research into the actual behavioral needs of farm animals.

4. We have an educational component to our program. Our scientific committee is available to answer questions from farmers on our program about their farm animals, the latest research on farm animals, how they can improve their practices and make life better for farm animals.

5. We are the only certification organization in the country endorsed by 66 humane organizations. We think this speaks volumes about the work we do for farm animals.

Most farm animals are raised under industrial agricultural systems where they often live their entire lives confined to tie stalls, gestation crates and battery cages, in order to maximize the producer's profit and productivity.

battery cages, gestation crates, or tie stalls. Animals receive nutritious diets without antibiotics or hormones and are raised with shelter, resting areas and space to support natural behaviors, such as perching or rooting, depending on the species of animal. Certified Humane<sup>®</sup> farmers also know it's not enough to say they are raising farm animals humanely; they know consumers want proof. So they join the Certified Humane<sup>®</sup> program, adopt our *Animal Care* 



Standards, and subject their farms to routine inspections in order to use the Certified Humane<sup>®</sup> label and show consumers that their animals are being raised according to verifiable humane standards.

When you buy Certified Humane<sup>®</sup> products, you are supporting compassionate farmers dedicated to bringing a higher quality of life to farm animals.

We just don't work with farmers raising farm animals, we also work with producers, like pet food and condiment companies, who want ethically-sourced ingredients in their products.
